- Current signed Passport (if you are not a UK national the Passport requirement with a valid visa is mandatory)
- EEA member state identity card
- Northern Ireland voter's card

#### **Proof of Address**

Original or certified copy of **ONE** of the following as proof of address:

- Utility bill (less than 3 months old)
- Local authority tax bill (valid for the current year)
- Current full UK Driving Licence (if not used for proof of Identification)
- Bank, building society or credit union statement (less than 3 months old) or passbook containing current address
- Most recent mortgage statement
- Electoral register letter confirming that a person of that name lives at the given address
